

Risk and reward profile



The assessment of risk and potential return of the Fund shown in the upper indicator is constructed in accordance with the methodology adopted by the European Securities and Markets Authority (ESMA).

Past data used in calculating the synthetic indicator of risk and return is not necessarily a reliable indicator of the Fund's risk profile in the future. In accordance with the actual operations of the Fund in the future, the assessment of risk and potential return may change over time, which can cause a change in the categorization of the Fund. Funds of category 4 have previously been medium volatile. The volatility shows how the value of the Fund's units has increased and decreased in the past. Considering the historical data of the volatility, the units of the Fund in category 4 may be exposed to medium fluctuations.

Fund performance in adverse market conditions may be affected by the liquidity risk, meaning the inability of the fund to timely liquidate assets which could lead to redemption delays. This particular risk is not adequately reflected by the Fund's risk and reward profile.




Basic chart over 36 months

Asset allocation by sector as at 31.01.2019




