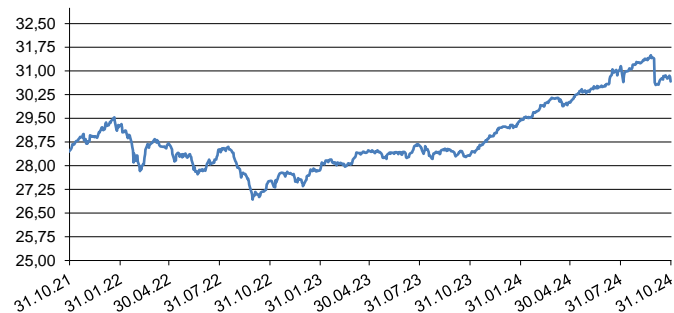

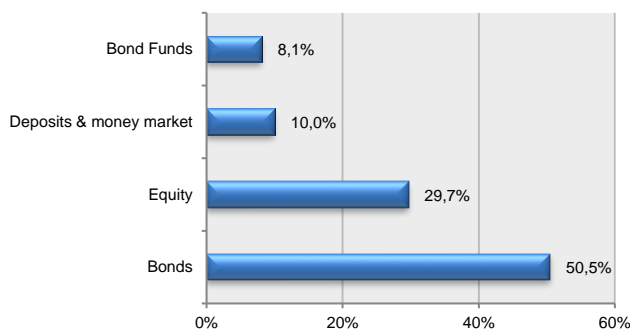
## Basic chart over 36 months



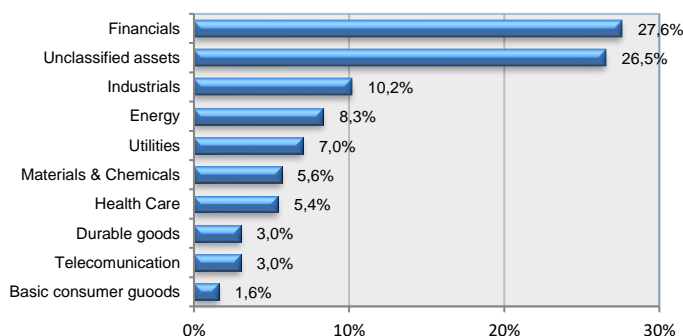

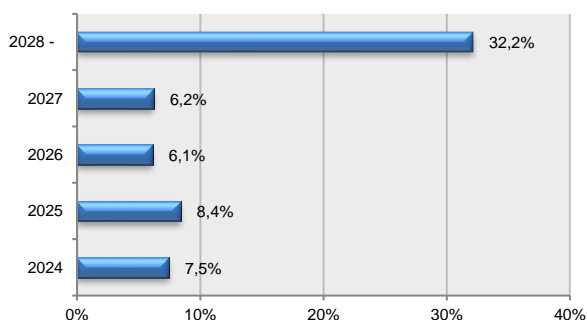
## Asset allocation as at 30.10.2024



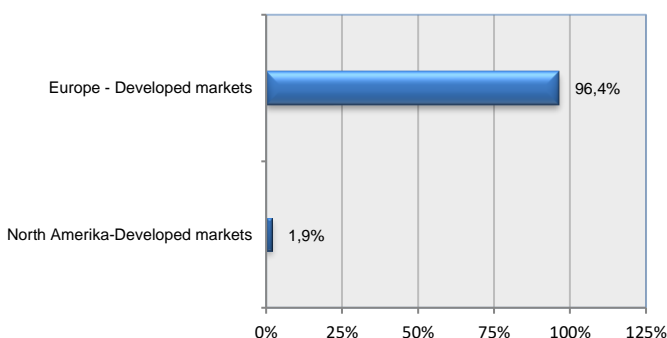
## Asset allocation by sector as at 30.10.2024
