




The value of bonds and bond-related securities can be affected by credit risk or changes to interest rates. Potential or actual credit rating downgrades may increase the level of percived risk.

Liquidity Risk – lower liquidity means there are insufficient buyers or sellers to allow the Fund to sell or buy investments readily.


Credit risk – the issuer of a financial asset held within the Fund may not pay income or repay capital to the Fund when due.

Basic chart over 36 months




Asset allocation as at 29.11.2019




Asset allocation by sector as at 29.11.2019
