

Liquidity Risk – lower liquidity means there are insufficient buyers or sellers to allow the Fund to sell or buy investments readily.


Credit risk – the issuer of a financial asset held within the Fund may not pay income or repay capital to the Fund when due.

Basic chart over 36 months




Asset allocation as at 30.11.2020




Asset allocation by sector as at 30.11.2020
