



The Fund is rated five due to the nature of its investments which include the risks listed below. These factors may impact the value of the Fund's investments or expose the Fund to losses.


The value of equities and equity-related securities can be affected by daily stock market movements. Other influential factors include political, economic news, company earnings and significant corporate events.

Liquidity Risk – lower liquidity means there are insufficient buyers or sellers to allow the Fund to sell or buy investments readily.


Credit risk – the issuer of a financial asset held within the Fund may not pay income or repay capital to the Fund when due.

Basic chart over 36 months




Asset allocation as at 28.09.2018
